



**GENERAL FINANCE CORPORATION DECLARES DIVIDEND OF \$2.30 PER SHARE ON ITS 9.00% SERIES C CUMULATIVE REDEEMABLE PERPETUAL PREFERRED STOCK**

PASADENA, CA – July 14, 2017 – General Finance Corporation (NASDAQ:GFN), a leading specialty rental services company offering portable storage, modular space and liquid containment solutions (the “Company”), announced today that in accordance with the terms of its 9.00% Series C Cumulative Redeemable Perpetual Preferred Stock (NASDAQ:GFNCP) (the “Series C Preferred Stock”), the Board of Directors has declared a cash dividend of \$2.30 per share. The dividend is the seventeenth dividend being paid by the Company on its Series C Preferred Stock and is payable with respect to the period commencing on April 30, 2017 and ending on July 30, 2017. This dividend is payable on July 31, 2017 to preferred stockholders of record as of July 30, 2017.
